Deposit Requirements

To reserve your court, a **\$400 deposit per hour** is required:

- 1.5-hour court: **\$600 deposit**
- 2-hour court: **\$800 deposit**

We ask that deposits be submitted as a **single payment**. If you need to split the deposit into multiple payments, please contact us directly, and we'll do our best to accommodate.

Please note: Your deposit secures your court time exclusively, ensuring it remains unavailable for others. As such, deposits are non-refundable.

When submitting your deposit, please include:

- **Captain's Contact Information:** Current email, phone number, and mailing address.
- **Additional Contact or Co-Captain Details:** Name, email, phone number, and mailing address

Payment Policy

- Payments are accepted after the captain submits a complete player roster and the total amount due per player, ensuring the total matches the full court fee for the season.
- If the captain collects payments from players and makes a single payment to the club, we only require a player roster, not individual amounts due.
- All individual payments must be received by the first day of play, regardless of whether the player is scheduled to play that day.
- If any payments are not received on time, the captain will need to cover the balance.

Important

- All balances must be paid in full by your **first day of play** (9/3/25 to 9/9/25)
- If any portion remains unpaid, the captain is responsible for covering the full amount and collecting payments from players directly.

Additional Information

- A complete player list is required prior to the start of the season to ensure all participants sign the liability waiver.
- While we will make every effort to meet specific court requests, we may need to reassign courts due to unforeseen circumstances. If this happens, we'll notify the captain in advance.

Cancellation Policy

- If your group needs to cancel for any reason, we kindly ask for **at least 48 hours' notice** to be eligible for a makeup session.

Makeup Policy

- A maximum of **3 makeups per season** will be permitted. While we always strive to offer flexibility, please note that availability for makeups is limited, particularly during evening and weekend hours.
- Please note that no-shows without prior notice will count toward your 35-week season and cannot be made up. To help us accommodate you, please notify us in advance if you can't attend—if you're eligible and within your makeup limit, we'll work with you to reschedule.

Requesting Additional Days Off

- You may request additional days off with advanced notice. Please note, however, that we can accommodate a maximum of 3 makeups per season.

Playing on Scheduled Days Off

- If your group wishes to play on a scheduled day off, this may be possible depending on the club's hours of operation. However, please note that this may result in your contract season ending earlier than originally planned if your group completes the 35 sessions ahead of the scheduled end date. Please call the front desk or email for inquiries.

Holiday Hours

- Club hours may be adjusted during holiday periods and breaks, and we may be closed entirely on select dates. Any schedule changes will be communicated in advance.

Contract courts run for a **fixed 35-week season**. Once play concludes and summer programming begins—such as USTA leagues and camps—court availability becomes more limited. We'll do our best to accommodate any remaining makeup sessions, though scheduling may be more challenging.
